# **EASTERN CORRIDOR PROGRAM UPDATE**

# A PUBLIC OPEN HOUSE HAS BEEN SCHEDULED FOR JULY 17

Meeting will focus on upcoming SR 32 Improvements between Eastgate Blvd. and Olive Branch-Stonelick Rd.

A public open house has been scheduled to discuss roadway and access improvements to the portion of SR 32 that extends between Eastgate Blvd. and Olive Branch-Stonelick Rd. in Clermont County.

The open house will be held at the following time and location:

The purpose of the meeting is to obtain public input on proposed improvement alternatives. The public is invited to visit any time during open house hours to view exhibits and ask questions; no formal presentation will be given. Personnel from ODOT, the Clermont County Transportation Improvement District (CCTID), and TranSystems will be available to discuss project alternatives, listen to the public's comments, and answer questions.

## **Project Goals**

This section of improvements to SR 32 (referred to as Segment IVa) is a core project the Eastern Corridor Program. The improvements being planned will work in conjunction with the construction now underway at SR 32 interchanges with I-275 and Eastgate Boulevard and other related projects to better support increasing traffic levels in the area; reduce congestion and traffic delays; improve access to and from local roadways, businesses,
